WHEREAS, Central Council's Business and Economic Development Department (BEDD) provides education and training opportunities for tribal citizens to enhance job skills as well as to find and retain employment leading to self-sufficiency; and

WHEREAS, Central Council BEDD develops and maintains programs to promote business and economic development opportunities for tribal citizens in Southeast Alaska; and

WHEREAS, Central Council will collaborate with Central Council's Office of the President and Communication Department to re-establish the logo wear activities; and

WHEREAS, Central Council will collaborate with Alaska Litho to develop the logo wear merchandise, branding and distribution of its apparel; and

WHEREAS, this will create a local and sustainable economic development opportunity for our Tribe, its tribal citizens and support other Central Council Departments; and

WHEREAS, specific logo wear apparel for Language Warriors will directly support the Central Council Language Department; and

WHEREAS, the Central Council Language Department was created at the 2014 Tribal Assembly through resolution 14-15 "Formation of a Central Council Language Department"; and

WHEREAS, Central Council BEDD is requesting \$5,000 in start-up funds to re-establish the logo wear from its Tribal Direct fund; and

WHEREAS, the \$5,000 start-up funding will be reimbursed to Central Council's Tribal Direct fund, as soon as possible; and

NOW THEREFORE BE IT RESOLVED, that the Executive Council hereby authorizes the Central Council President or the Chief Operating Officer to submit, negotiate, execute, and administer any and all documents required for granting funds to the BEDD for the proposed logo wear project.
