

## Rules and Regulations

### **Artist Elizabeth Peratrovich Hall Space:**

1. All artwork displayed is required to be original artwork produced by the artist(s).
2. Artist should be set up at 8:00 a.m. and close down at 5:00 p.m.

### **Artwork and Materials:**

1. Eagle feathers may be possessed with a permit issued by the U.S. Fish & Wildlife Service, but may not be sold.
2. The Migratory Bird Treaty Act prohibits the possession or sale of migratory bird feathers or parts.
3. The Marine Mammal Protection Act (MMPA) requires that marine mammal products be "significantly altered."

### **General Requirements:**

1. No dealers, traders, or agents may participate in the market.
2. Food preparation or sales are not permitted.
3. The Native Artist Market is alcohol and drug free. Violators will be asked to vacate the premises.

### **Native Artist Waiver, Release and Certification**

1. I agree to hold Central Council Tlingit & Haida Indian Tribes of Alaska (Central Council), its employees, officers, and volunteers harmless from any and all claims I might have for personal injury or damages to or loss of my property while participating in the Central Council Native Artist Market or Juried Art Show.
2. I agree to comply with applicable federal, state and local laws and tax codes.
3. I agree to comply with Southeast Alaska Native traditional laws in respecting clan ownership of crests, names, songs and other such cultural and intellectual property of clans.
4. I certify I am a tribal member and this will be confirmed by Central Council Program Compliance.
5. I have enclosed the agreed upon fees as applicable.
6. I certify I am the original artist of all work to be sold or displayed at the selected Central Council Native Artist Market.
7. I authorize the use of my name, biography, and address for educational, promotional, or cultural purposes or public requests for names of artists.
8. A follow up survey will be sent to artists, with estimated revenue earned by each artist to Central Council. This information will be used to plan training and marketing opportunities for artists.
9. I agree to comply with applicable federal, state and local laws and tax codes.
10. I agree to comply with Southeast Alaska Native traditional laws in respecting clan ownership of crests, names, songs and other such cultural and intellectual property of clans.
11. I certify I am a tribal member and this will be confirmed by Central Council's Program Compliance department.
